Graphics exchange format AutoCAD DXF drawing format exchange is based on the graphic exchange format (GIF) of the Windows Graphic Device Interface (WGDI). AutoCAD DXF files may have a different size than the AutoCAD drawing file. Drawing information in AutoCAD is represented as a series of blocks which are grouped into entities such as layers, frames, and components. The number of blocks are called block count. Autodesk AutoCAD DXF file does not have blocks, but have a single type of blocks. Transparency The degree of transparency is represented by the opacity of an object in a layer. All the objects, regardless of their opacity, are drawn in the background so that they are revealed when the foreground objects are drawn. Each layer has its own layer color. In the latest release of AutoCAD the opacity of the layer is not limited to 0-100%. The opacity is limited by the layer color. It is the foreground color which limits the opacity of the layer. Objects on top of an object with a higher layer color will have their opacity increased. There is no limit to the maximum opacity of any one layer. If a layer is filled with a gradient, it is possible to make that gradient semi-transparent by reducing the layer color. The gradient's opacity is therefore determined by the layer color of the object it fills, even though it is in a semi-transparent state. Layer properties The layer properties refer to the display and printing of the layer. If the layer is to be printed, then the properties used to print the layer are printed along with the layer. For example, if the object in the layer has the Fill Color property set to White, then the layer will be printed in white on a color printer. If the layer is not being printed, then its name and the display properties are shown. Layers with the same layer name and same display properties are grouped together in a work area. An object that has the same layer name and display properties as a given object will appear as if it is part of that object. For example, a group of related objects all have a layer name of "Road". If one object has the Fill Color property set to White, then all objects in the group will have the same Fill Color. If the Fill Color of an object is changed in a group, then the Fill Color of all objects in the group will also

The court further found that these financial statements were "substantial evidence" of substantial economic misconduct because they demonstrated that Teresa knew she had substantial financial assets that were not fully disclosed and that she had failed to use these substantial assets for the benefit of the marriage. As to the allegations of Debra's economic misconduct, the court found that: (1) Debra engaged in more than one "practical joke" on her husband; (2) Debra refused to take her husband to the hospital when he was seriously injured; (3) Debra lied about her relationship with Coleman; and (4) Debra twice falsely told her husband that she would not permit him to take the children to Colorado for their summer vacation. The family court found that these acts were acts of economic misconduct because they were sufficient to jeopardize the very financial security of Teresa's own family. See Edwards, supra. In making these findings, the court was undoubtedly influenced by the fact that Teresa failed to use her own substantial economic misconduct to demonstrate why she should not be forced to make a larger share of the marital estate available to her husband and daughter. However, the court's findings were made after a full and fair hearing, and the record clearly supports those findings. Therefore, the court properly ruled that
